**CUSTODY**

**LEGAL CUSTODY-** Custody is a very important issue. By far the majority of cases provide for joint legal custody. This allows both parties access to school and medical records. In addition, the law provides that the parties will consult on major decisions related to the children. This does not mean that you have to consult about day-to-day issues.

**PHYSICAL CUSTODY-** Is where the child or children primarily reside. Typically it is one parent or the other and the person that does not have physical custody has visitation or is considered the "secondary caregiver"
